Unlike Round 1 funding, for CRRSAA, GSU did not require students to apply, but rather we distributed monies to the students using spring semester census to develop a matrix based on three primary factors: financial need (Pell / MAP eligibility as shown on the FAFSA), full or part-time status, and undergraduate / graduate status. Below is the matrix of how awards were determined for CRRSAA. **For ARP, the matrix is still forthcoming based on the Fall 2021 census.**
