

Associate in Arts to Bachelor of Science in Health Informatics

The following is presented as an articulation agreement between City Colleges of Chicago (CCC) and Governors State University (GSU) for the Health Informatics degree program based on the current catalogs of both schools. The student would receive an Associate in Arts (AA) degree from one of the CCC and a Bachelors of Science (BS) degree in Health Informatics from GSU.

Students are required to have a 2.75 G.P.A. for admission to the program.
