Dr. Ferran is the Director of Accreditation and Assessment (equivalent to Associate Dean) and a Full Professor of Accounting and Management Information Systems (MIS) at the College of Business of Governors State University. He has been there since 2010. He taught at Pennsylvania State University and Rochester Institute of Technology. Dr. Ferran obtained his doctoral degree in Business Administration (MIS) from Boston University. He is a Certified Management Accountant (CMA) and Certified in Strategy and Competitive Analysis (CSCA). Before entering Academia, he was the Chief Information Officer (CIO) at a major financial institution in Venezuela, a Director of a Software Development Co., a planning and financial analyst in the Venezuelan oil industry, and a manager and developer of banking and accounting applications at a software company. His professional career started developing accounting applications for the Apple II. He earned the Venezuelan Academic Excellence Award *Antonio José de Sucre* and the *Fundación Gran Mariscal de Ayacucho* scholarship.

Dr. Ferran has published 15 peer-reviewed articles, five peer-reviewed book chapters, and 18 peer-reviewed conference proceedings. He authored a book and co-edited an academic book on Global ERP. His paper titled *Videoconferencing in the field: A Heuristic Processing Model* was published in *Management Science* and was cited in over 150 news outlets on the first 60 days following its publication and his conference proceeding titled *Teams or Communities? Organizational structures for knowledge management* has been cited in over a hundred academic articles. He has also presented at numerous national and international conferences where four of his presentations have won the Best Paper Award. He is a member of the advisory board of five international journals and the founding editor-in-chief of RELCASI –a journal of the AIS—. He chaired tracks in AMCIS between 2009 and 2016. Dr. Ferran is the co-chair of AMCIS 2019, Past-President of the Latin American and Caribbean Association for Information Systems (LACAIS), and of the Accounting Information Systems SIG of the AIS (SIGASYS). Dr. Ferran is a peer reviewer for the Higher Learning Commission, ABET, MERLOT, and QM.

Dr. Ferran has fully developed over 20 high-quality online courses. He has also taught and given academic lectures in English and Spanish at universities in Argentina, China, Colombia, Costa Rica, Mexico, Spain, United States, and Venezuela.
