Financial support documents must be provided. This can either be in the form of a bank statement, savings deposit or certificate of deposit showing an amount of \$18,000 US dollars or the equivalent to \$18,000 US dollars in your home country currency. Financial support evidence must be dated no earlier than 6 months from the time you apply to the university. You must mail a hard copy to GSU, Office of International Services, 1 University Parkway, C3370, University Park, IL 60484. GSU will keep this hard copy for their records. An immigration document or I-20 will not be created for you until you send the original financial support documents to the university. You will need another copy of the financial support documents to take with you for your visa interview when you receive your immigration document or I-20 from GSU.
