

Associate of Arts to Bachelor of Arts in Criminal Justice

The following is presented as an articulation agreement between Morton and GSU for the Criminal Justice degree program based on the current catalogs of both schools. The student would receive an Associate in Arts (AA) degree from Morton College (MC) and a Bachelors of Arts (BA) degree in Criminal Justice from Governors State University (GSU).
