**STRATEGIC PLAN**

**Introduction:**

Transforming, Educating, & Empowering Children and Humanity (TEECH) is a 501c3 organization that has provided life skills education, employment training/coaching, and recovery- based education/support within the communities since 2002. As a result of their experience, diligence, and outcomes they were chosen to formulate a Recovery Systems of Care (ROSC) council on the Far Southside of Chicago. The council aims to create a platform for congruency and unity within the communities, emphasizing substance use and mental health issues.

According to recovery advocate and author, William White, ROSC is a "coordinated network of community-based services and supports that is person-centered and built on the strengths and resilience of individuals, families, and communities to achieve abstinence and improved health, wellness, and quality of life for those with or at risk of alcohol and drug problems." This paradigm shift is being introduced to family, friends, and the community as a steppingstone to increase long-term recovery for those impacted by substance use.

FSSRI/TEECH aim to bridge the gap with those in recovery, attempting to get into recovery and those with mental health issues by addressing stigmas and stereotypes while encouraging persons with lived experiences (PLE's) to use their voices to obtain necessary assistance to ensure they receive a good quality of life.

**Update year 1:** The Far Southside ROSC Council has vigorously worked in year 1 (one) at educating the community about substance use, mental health, stigmas, and stereotypes while ensuring PLE's had a voice at each meeting and advocacy projects. The council has accomplished buy-in from the communities in year 1 (one) as evidence of breaking the code of silence as discussions of addiction, overdoses and violence have become an extensive dialogue in the meetings. The council will continue its goal of providing a platform that will allow for congruency and unity within the communities, emphasizing substance use and mental health issues throughout year 2 (two) of the Far Southside ROSC Initiative. In Addition, the council will continue bridging the gap with those in recovery, attempting to get into recovery, and those with mental health issues with a continuation of education and using the PLE's voices in meetings and all projects that the Far Southside ROSC Council engage in year 2 (two) of the initiative.

**Update year 2:** FSSRI continues to accomplish buy-in and what appears to be trust with the community, family, friends, and the organizations as they continue to attend the meetings, hire PLE's and work together to bridge the gaps identified in the survey. However, 9 (nine) months into the year, the communities were stricken with the Coronavirus and rioting, which caused great uncertainty and a need to switch the focus of the FSSRI ROSC Initiative. Whereas, seeking someone to blame for the looting and destruction of properties, they began to lean towards stigmas and stereotyping of those in addiction and those with mental illness. The PLEs hired through many of our partner's employment working hours began to decrease, and many were laid off, leading the FSSRI ROSC Council to step in and assist in providing resources for financial assistance, food, clothing, and co-payments for medications. The council members are very connected with the PLEs, who were allowed to break.

down the stigmas and stereotyping as they used their voices during this time of deprivation. The PLEs broke down stigmas as they assisted in clean up after the riots, assisted the elders with obtaining medications, snow removal, and passed out PPEs. They were also instrumental in developing website information to ensure resources were readily available during this devastating time.

The council strengthened its collaborations in year 2 with those in active addiction, recovery, family, and friends during the COVID virus. We were one of the only recovery-based programs on the Far Southside of Chicago that continued with face-to-face services while addressing community barriers. In addition, the PLE's became the boots on the ground, referring those who needed detox, treatment, employment, and other resources. TEECH maintained financial stability by gaining trust in the communities, which provided donations to assist with PLEs and community needs. The FSSRI will continue bridging the gap with those in recovery, attempting to get into recovery, and those with mental health issues with a continuation of education and using the PLE's voices in meetings and all projects that the Far Southside ROSC Council engages in year 3 (three) of the initiative.

**Year 3 Update:** TEECH assisted in getting the communities to engage in broader collaboration, allowing for additional and better service for those in active addiction, recovery, family, friends, and the community. Doors opened in communities that allowed for barriers to be addressed, such as a recovery home was opened in Morgan Park, a dollar store, and a grocery store was opened in Auburn Gresham. And hospitals became more involved and attentive to those with substance use and mental illness issues. The communities came together to assist one another with needs to ensure the children had back to school and other items needed to assist with their barriers. They also assisted elders with groceries and parents with the formula for the babies when there was a shortage. Also, we have been working diligently with the HIV/AIDS organizations, and it appears they are moving to expand their services in a broader compacity for those in active addiction, recovery, family, friends, and the community.

The FSSRI will continue bridging the gap with those in recovery, attempting to get into recovery, and those with mental health issues with a continuation of education and using the PLE's voices in meetings and all projects that the Far Southside ROSC Council engages in year 3 (three) of the initiative. The Far Southside ROSC Council has vigorously worked in year 3 (three) at educating the community about substance use, mental health, stigmas, and stereotypes while ensuring PLEs had a voice at each meeting and advocacy project. **Year 4 Update:** The Far Southside ROSC Council has continued to work within the communities in year 4 (four) while educating those in active addiction, recovery, family, friends, and the community about substance use disorder, mental illness, harm reduction, stigmas, and stereotypes while ensuring PLE's were active participants and used their voices to assist with creating change and addressing barriers. During this year, we have assisted with community barriers, such as coordinating with Alliance Care 360 and the Center for Disease Control to distribute HIV Take Home Tests to the communities whereas, passing out over 2,000 kits. Along with increasing our Narcan distribution and education to organizations and homes. We were also instrumental in getting another recovery home in the Roseland Area, creating a ROSC on the Southeast Side of Chicago, and Enhancing the Youth program with Gro Community Services with a youth recovery home, training, counseling and trauma therapy in the Roseland area and getting their voices out to assist with curving the violence. In addition, we expanded TEECH recovery support services with the Cook County Correctional Electronic Monitoring Department and the Restorative Justice of Englewood. Lastly, Clergy has begun to step up and open doors for more community meetings, Pete's Grocery has finally broken ground, and the Alderman's are catering more to the communities and addressing barriers such as projects for the youths, elderly, and returning citizens while looking at ways to rebuild our communities. The council will continue bridging the gap with those in recovery, attempting to get into recovery, and those with mental health issues with a continuation of education and using the PLE's voices in meetings and all projects that the Far Southside ROSC Council engage in year 5 (Five) of the initiative.

**YEAR 1**

**Goal A: TEECH Will Formulate a Team to Develop the ROSC Council.**

**Outcome:** Goal Met

**Objective 1:** The lead agency will assign roles and ensure the team understands ROSC.

**Update:** TEECH assigned roles that correlated with leadership skills promoting an encouraging and positive learning experience.

We brought in needle exchange, Naloxone and medication give away which seemed to spike the increase in community participation opening the doors for the much-needed education on stigma, substance use and mental health.

The ROSC initiative appear to have developed a safe place for the community to share their issues without being judged but solution focused. The ROSC initiative has proven affective as we have reached the goals set for year 1 (one) and provided answers for many of those who reside in the communities. Therefore, we will continue in year 2 (two) to follow the strategic plan that has been put developed.
