Old Business John	John walked the group through some 2023 highlights for the pillar groups of Prevention, Support & Recovery. A few top Recovery activities included the Washington Co. Drug Court, SUDS laundry event, Meth Panel presentation, SORN Walk for Recovery, sticker campaign, & several pop-up events. The Recovery group also assisted in formation of a deflection program and were able to collect SUD Needs Assessments.	
New Business John	Looking forward for 2024, John advised that a Calendar has been created that includes Recovery activities. Currently, the calendar includes the monthly ROSC Recovery meetings, attendance of the monthly Mobile Market in Chester (4 th Wednesday of the month), Bi-monthly HCA displays at local libraries (Dennis & John will alternate) and the grand opening of the new Resource Center on March 18 th . There are also three pop-up events planned for 3/20 (Coulterville), 4/17 (Chester) and 6/11 (Nashville).
