- I. Heather opened the meeting by going over the agenda and then introducing our guest speaker Armando Miranda from OMNI Youth Services as a Prevention Specialist. Armando OMNI is a mix of things, it's a mental health agency in which they work with clients in Buffalo Grove, but they have expanded their services into Southern Central and Southeastern and southwestern IL. Armando operates under two grants, the State Opioid Response and SUBS, for human performance projects. OMNI is reaching out to Greene & Scott counties to offer a variety of services. Materials that we need can be printed and sent over to help educators, parents, coaches, and adolescents to educate them on the importance of understanding safe disposal, safe storage, and usage of medications. We'll be able to coordinate and collaborate with OMNI and they can tailor materials to what we need in Greene & Scott. Omni is in the works of becoming accredited so if any health educators in the community don't have materials to host fentanyl training with students or a curriculum, OMNI would be able to develop those materials to make it easily implemented in the schools.

  - Hosted a game day event, an idea brought up by peers.

### III. Outreach

- Heather is working with local manufacturers to streamline the employment process. GSRC will be the primary reference to get peers back into work.
- Heather is partnering with ROE 40 and Lewis & Clark Community College to get peers connected to complete their GED. I will gather the number of peers interested and then an Introduction meeting will be held so individuals can learn how to get signed up and what all in entails.
- Heather has been reaching individuals at the food pantries in Carrollton, Kane & Eldred

### IV Community Health Updates

- Ron shared the data based on the number of peers the Recovery Support Team has been seeing since January. They had 190 service entries. Out of those entries, 74 were office visits, 41 were teleservices/telehealth, 32 were outreach/education consults, 26 were transportation assistance, 6 were resource linkages, 6 were field response visits, 5 were OD training (Naloxone) 106 doses distributed. The month closed with 68 total participants.
- We discharged two participants due to a drop in contact, and not participating in meetings and events. There's always a chance they'll reenter the program in the future. We welcomed 13 new participants.
- MAR Clinic-2 service dates and 8 patients.
- MAR Program-2 patients successfully linked with MAR prescriptions.

#### V. Billboard Advertising

-Ron and Heather proposed the idea of advertising mental health and substance use recovery on a billboard. The image on the slide is the original image that the advertising company said was too busy, so the wording underneath indicating services has been removed. Ron discusses the budget and production costs for the billboard. The council votes anonymously approving the billboard advertisement.
