Spotlight Speaker/Agency: Kristin Davis, Family Guidance Center

Along the way, a suggestion was made to her that she should apply at the Hour House. She felt like she could be doing more for people. She got the job! She went into prevention July of 2007. She worked from just about every angle besides working at the Shelbyville Office. In July of 2022, she went and taught in the alternative schools and was really grateful for it but decided it was not for her. She now works for Family Guidance Centers. She serves the areas from Quincy to Paris.

Strategic plan review

Tess spoke on objective 9 from the strategic plan. We want to continue the discussion on starting Safe Passages in Moultrie/Shelby county! **Tess** also spoke on objective 13. MSCRC wants to provide community wide education series to reduce stigma surrounding substance use disorder. Recovery Navigator Resource Update:

Skylar stated that wellness groups are available to the public via zoom on 3/14/24 and 3/28/24. She also has her wellness groups at Restoration Farms. She will be sharing her story with the students that attend Bridges in Shelbyville on the 14th. Skylar attended and graduated from Bridges in Lerna so this will be really personal experience for her!

The MSCRC spoke at Shelbyville High schools Rise Above Day as the keynote. We were also an option for the breakout groups that they provided, and we received amazing feedback!

Skylar mentioned that she continues to work with the Moultrie County Jail every Wednesday. She has recently been meeting with the first woman at Restoration Farms (a recovery home in Herrick, IL).

What's Next?

Skylar mentioned that our next laundry day will be on March 29th. We will be there providing Narcan, Narcan training and education/resources regarding substance use disorder.

Skylar also stated that our Second Chance Employment Fair will be held on April 11th in Sullivan.
