Skylar mentioned that she continues to work with peers at Moultrie County Jail, and in person/via zoom with the women of Restoration Farms; which is an 18-24-month faith- based transitional home for Women and children located in Shelby County.

Skylar also mentioned that our next laundry day will be on May 24th. We will be there providing Narcan, Narcan training and education/resources regarding substance use disorder. Our most recent Laundry day held on March 29th was the most attended to-date, 2 boxes of Narcan were supplied as well as information provided. Several loads of laundry were washed and/or dried, and we are grateful to those who donate and make these events possible.

Skylar has been spending time preparing for our Second Chance Employment Fair. She then expressed gratitude to those who have donated clothing for the business casual drive that will support the employment fair.
