- The subcommittee is still focusing on gaining access to individuals by connecting H&I and by connecting individuals through pre-trial meetings. We will also be working to collaborate with HMA's Jail MAR programs. We are looking at how we can start accessing the county jails and look at what reentry programs are available for individuals and meeting their needs.
- Mark Knott and Tyron Hill are hosting weekly support meetings at Amare's Wood River location each Tuesday at 6:00 pm. They have also expanded into St Clair County with a 1-hour group at the IRC.
- Jakob Miller from the IRC- Illinois Recovery Center in Swansea gave relevant information on the services they can provide at this time. Residential (28 days), medical detox up to 2.7 & Alumni support of 6 meetings/activities a week.

New Business

This month Alida Barela – AMARE nfp – updating the group on what AMARE's expanded services since first starting, what AMARE does in the community and how they can help your team in their mission.

Alida shared some of her personal story of recovery and how she has transitioned into being a Recovery Specialist with AMARE. She shared how she and her coworkers take a client centered approach at meeting the individual looking for help is at, what help looks like for that individual and what Recovery looks like for said individual. This approach has led to several positive outcomes for individual's with SUD (substance use disorder).
