# **Agency Updates**

Julie Pohlman mentioned that she is looking forward to all of the changes that will come in FY25 and that we got to meet in person at Statewide ROSC last month!

### Spotlight Speaker/Agency

**Randi Moberly** shared information regarding her organization and coalition. She went on to list the IL RCCA Objectives: program support, selection, contracting, implementation, and regional coalitions. She also mentioned that The Opioid Settlement Funds Website is the key resource and designed to bring transparency to the spending of the funds.

Julie Pohlman asked if the presenters could share their slides. Randi answered yes, she would be happy to share them after the meeting.

**Meagan Washington-Sims** discussed that she is having individual meetings with the ROSCs in her region. She then went on to discuss the barriers that Moultrie/Shelby counties face. The barriers included transportation and stigma. She had mentioned that Tess and herself had a meeting discussing ways in which these barriers could be reduced. **Meagan** shared the coalitions work plan with the council and reviewed the barriers surrounding substance use that were developed into her workplan. **Meagan** mentioned that the coalition will be meeting on June 13<sup>th</sup> from 11-1. **Tess** then mentioned that the MSCRC is always looking for placement on DOPP sites. She stated if anyone knows of and individual and/or agency that would benefit from a site to please let her or Skylar know.

### **Barrier discussion within Moultrie/Shelby Counties**

**Tess** mentioned that there were many identified in a previous meeting, therefore, we are going to highlight one a month, and discuss indicators of change.

**Skylar** reviewed our previous barrier discussion in May. She stated that from this discussion we realized that the community *does* have a sufficient amount of sober activities. It is just that not everyone knows of every event that is happening. Therefore, Skylar and Tess, along with the MSCRC will do there very best to get the word out on events coming up via social media and email. The MSCRC will also partner with local agencies and become supplement in hosting/attending events.

**Tess** had mentioned that one barrier is that homelessness issues are typically ignored throughout the community. She asked the council what their thoughts were on this barrier.

**Susie Kensil** mentioned that she does not think it is necessarily ignored, however, she does believe that there is a lack of resources and funding to help those individuals who experience homelessness. She highlighted in one year the Shelby County Salvation Army placed 27 families in furnished homes/shelters. Susie mentioned that there are great organizations helping with this barrier. CEFS and

the Salvation Army help immensely. She then went on to state that it is important to volunteer to be a bell ringer for the Salvation Army, that is where they receive their funding.

**Tess Miller** thanked Susie for the valuable information. She then stated that she appreciates the discussion, and that we will work with the council and partner with CEFS and Salvation Army to reduce this barrier. **Tess** mentioned that Back to School Event. She said that they are partnering with the Salvation Army to provide hygiene kits and Narcan/Narcan trainings.

**Tess** mentioned that Skylar and herself has been working on an accomplishment sheet, that highlights all of the accomplishments from the MSCRC in the past fiscal year.
