### **Meeting Notes:**

- Brief discussion: Start with Hope, but Don't Stop There: Conversations on Black Recovery panel discussion
  - o *Slides attached*
- Strategic Plan review: Admin & Outreach committee proposed FY25 tasks
  - o Discussion: need for clarity on ROSC goals, mission – what is our purpose and how are we measuring success, iterating on learnings?
    - Organizations and stakeholders benefit from having a space to partner with others, learn about each other's services, and collaborate – how can we make sure we are doing this?
    - In need of a roadmap to bring us in a more concrete direction this year
  - o Question: What are our ROSC deliverables?
    - Monthly meetings, membership roster, monthly/quarterly/annual reports, strategic plan (annual), community needs assessment (annual)
  - o Outreach committee has proposed a newsletter and member presentations on monthly meetings
    - Generally like the idea of member presentations – add value, facilitate collaboration

- Newsletters are hard to maintain, take a lot of work – quarterly seems like a large commitment
  - New idea: need to collaborate on Narcan distribution/education - who is doing this, how do we keep track of distribution sites, resupply, community-level access?
    - Will add to FY25 task list and start working on this at July meeting
    - FGC, Sangamon County HD will start planning process on this
- Reviewed proposed new member orientation/onboarding process
  - Generally the group likes the process, agrees that we need members to commit to a certain level of attendance, participation
  - Discussed the sectors and how individuals can choose to identify
- Open Announcements/Discussion:
  - Sangamon County Health Department is working with Coroner, IPHI, and CDC Foundation to start a fatal overdose review board. Still in early stages, Joan will keep ROSC committee updated as it progresses, how members can participate/stay informed
