Spotlight Speaker/Agency

Presenter: Camille Gordon – Director of Outreach and Prevention at HOPE of East Central IL

Camille Gordon discussed her role and the mission/values behind her organization. She mentioned that the shelter is a 45-day shelter. They have a crisis hotline, transitional housing, children's programs and much more! HOPE aims to help those that suffer from domestic violence, and give them a safe place to live. HOPE services seven counties, excluding Effingham County. HOPE also has a contract with Rise. This contract allows an in-house counselor to be available at HOPE. **Camille** also hosts groups at the Hour House in Charleston. She also mentioned that they tend to be busier around this time of the year. She also stated that they opened up an office in Edgar County and the other four offices are in Charleston.

Tess Miller asked if it was typical for the summer months to be busier?

Camille Gordon stated that it is typical for the summer months to be busier than winter. She says that this could be because the weather is nicer and individuals can walk. Some individuals do not have transportation.

Tess Miller then mentioned that the MSCRC is always looking for placement on DOPP sites. She stated if anyone knows of and individual and/or agency that would benefit from a site to please let her or Skylar know.

Barrier discussion within Moultrie/Shelby Counties

Tess Miller discussed the previous barrier discussion in June. She stated that individuals have stated that homelessness is typically ignored. However, we learned from our prior discussion that it is not necessarily that it is being ignored; It is that there are not enough resources to go around. Organizations that can aid in this concern is CEFS, DOVE Inc., Salvation Army, local churches, etc. ROSC will aid in continuing to being that dot connector.

Tess Miller mentioned that this month she is going to open the discussion about the stigma that surrounds substance use disorder. **Tess** mentioned that stigma is still very prevalent within Shelby and Moultrie counties. She mentioned when calling individuals regarding attending the second chance employment fair, she heard frequently that "we do not want to hire *those type* of people". She wishes to find ways to reduce the stigma and find ways to approach individuals that have stigmatizing language.

Rebecca Comstock mentioned and instance where one of her clients were stigmatized by a person in authority. She mentioned that she felt very sad for her client for having to sit through a situation like that.

Camille Gordon stated that the stigma is prevalent across various populations.

Tess Miller asked Liesl to give a brief summary of her training that she hosts. She facilitates the Drug and Endangered Children/Human Trafficking training.

Liesl Wingert discussed the training briefly and gave some dates that she will be facilitating the training. However, she did say that if we wanted to schedule a training with her, it would be free of charge covered by SIU.

Tess Miller mentioned the potential to gather various organizations that were interested and schedule a date

Communication Campaign Introduction

Tess Miller discussed their communication campaign. This campaign will be implemented by all counties that have a ROSC Council under their lead agency the Hour House. This campaign aims to reduce the stigma and increase the education surrounding substance use disorder and recovery. **Tess** mentioned that as of now we have had 63 responses to our survey that we sent out with the introduction of the campaign.
