Old Business:

FWRC EDDM (Every Door Direct Mailer) Outreach Campaign:

- Mandy states that people have reached out to her through phone calls and Facebook messenger and that many of them were unaware of our resources in our communities including those offered by Take Action Today, Gateway and Centerstone. There were several people that said they were lonely and bored and would like to volunteer for our organization at some point. Mandy will personally reach out to those who provided their contact information to help volunteer at future FWRC events.

Recovery Month Idea Updates:

 - Aaron Seibert shared that Centerstone in partnership with FWRC are working together to light up the square in Marion purple for recovery month.

FWRC Strategic Plan:

Mandy went over the finalized 3-5 years FWRC Strategic Plan.

Chrystal Cantrell on behalf of the FWRC gives thanks to the people who helped make the strategic plan possible through focus groups and social media. She also shares that this year there is a huge movement towards helping with the homelessness issue. Chrystal shares that the members of this ROSC are vital to help share and spread potential resources and solutions to our community. She also thanked Sherry Smedshammer for helping form the outline for this year's strategic plan.

New Business:

The next meeting for the FWRC will be held at the Take Action Today resource Center located at 905 W. Washington St. Benton IL. The plan for this Fiscal Year 25 is to hold more meetings in Franklin County.

Aaron shared that Walgreens in Carbondale and Murphysboro are dispersing free prenatal vitamins to those in need. To receive these items an individual does not have to be pregnant. He is hoping to get other locations on board and will inform the council if other locations that he finds are participating.

Christina Manchen announced Centerstone has formed an advisory council known as the Voices in Action Council (VAC).

- The purpose of the council is to examine our communities' mental health and substance use needs and determine Centerstone's capacity to address the needs of the population being served. Individuals with lived experience must make up 51% of the council with the remaining members coming from community agencies such as yours. I would like to invite you or someone from your agency to join the council to share your voice as we aim to improve the way Centerstone provides services that better meet the needs of individuals and the community.

Hank Roan shared about the upcoming SIRN website release. The website will have an interactive map of the lower 18 counties in Southern Illinois. When you click on a county there will be a list of available resources with location available to the individual. He states we are hoping to get plenty of resource centers and agencies to fill out these contact cards that will be generated through a click.

Wendy Lambert Shared about 2 events happening in Danville, II. Ride for Recovery in August and an End the stigma event in Sept.
