# Minutes

## Introductions

Council meeting attendees introduced themselves and agencies they represent or reason for being present.

# ROSC Coordinator/Recovery Navigator update

- ROSC is a Chamber member now-- New member picture was taken at this meeting.
- Proclamation from the Mayor Aug 28<sup>th</sup>- SEPTEMBER IS NATIONAL RECOVERY MONTH!
  - Samantha H. stated her and Felicia will be at City Hall on August 28<sup>th</sup> at 1:00pm for the reading of the proclamation and picture with Mayor Schutzbach. Anyone from the Council is welcome to attend.

#### Communication Campaign

  - Samantha stated if any client's or people the Council knows would like to share a bit of their story on FB Live or on our Cromwell media ads, let her know!

### Surveys

Samantha H. asked the Council how they think we should distribute surveys.

- Social media was discussed. Many mentioned which media platform targets what age group—e.g. Facebook is used by Boomers, Millennials, Instagram, TikTok, Snapchat used by Gen Z, Gen X, etc. Samantha asked if anyone has these accounts already and would be willing to post a survey to it.
- Olivia suggested to make a QR code.
- Megan E. suggested we get in contact with Bryant Laiche who oversees the Youth Advisory Board at Prevention First and ask their opinion on surveys and social media in general.
- Samantha H. asked if the Council would be willing to pass out surveys to their clientsresponse was yes.
- Olivia suggested health classes in the schools- Samantha said she'd reach out to EHS resource officer to input.
- Samantha H. also said ROSIE newsstand, gas stations, library, newspaper anywhere someone could scan a QR code. Samantha also mentioned and incentive for people who took the survey such as a donated item they could be entered into a drawing for if they take the survey.
- Beth W. mentioned that Microsoft now has a similar platform for surveys like Google forms.
- Samantha H. asked how many questions MAX the Council would like the survey to have—response was 10 questions.
- Johanna stated that SUPR will have some questions they want the Council to include per our FY25 Deliverables as well.

## **Opioid Settlement Funds**

Samantha H. briefly went over the opioid settlement criteria document and asked if the Council has any suggestions or connections as to what organization would be a good fit for applying for the funds.

- Someone suggested El Shaddai for the pregnant and postpartum category.
- Jeff W. stated the county board may come up with 2 committees for this—1 would be
  potential interested candidates, and the other would be a committee with members
  who have no conflict of interest (aka, not applying for funds.) He stated there is a
  County Board meeting today where this is the first topic on the agenda. Samantha and
  Felicia will be attending this meeting.

#### Strategic Plan FY25

Samantha H. asked everyone in person to rank their top priorities numbers 1-3 on the document passed around. Samantha also asked Zoom attendees to email her with their 1-3 rankings as this document will be updated and added to soon.

Beth W. mentioned the need for more people available or able to do SUD assessments.
 Samantha described the process of an assessment at Hour House and stated they do

assessments over the phone. Beth stated transportation has been a barrier as well as waitlists for the actual assessment and treatment.
