Organization Spotlight/ Guest(s)

Zach Nichols, Commander, East Central Illinois Task Force, Division of Criminal Investigation, Special Operations, Illinois State Police. Zach is in his 16th year in law enforcement with the Narcotics task force over Coles and Douglas Counties.

Zach provided an overview of the program timeline. Illinois State Police (ISP) had their 100th anniversary in 2022. It was created during prohibition and used WWI motorcycles. Initially the department faced a

lot of challenges, including combating complexities of modern policing. There are a broad range of responsibilities including Drug enforcement and Counter terrorism. ISP has adapted to meet challenges of organized crime and corruption. Today, ISP tries to uphold mission. Division of criminal investigation (SOCOM) has 22 multipurpose narcotics enforcement units and have branched out to become involved in trafficking.

Central Illinois Task Force is under the supervision of ISP since 1999. Daily operations complex and multifaceted. There are a variety of activities designed to disrupt drug trafficking including informants and surveillance that helps understand supply chains. Through Intel connections, they can look for patterns. Coordinates with FBI and DEA for undercover operations to infiltrate drug networks. Requires meticulous planning to make a bust and collect document evidence, seizing drugs and weapons. Proper documentation key to successful prosecution. It is estimated that 90% of violent crime comes from this type of work. The department also provides community outreach and prevention and educates public about drug abuse.

Deflection is a strategy redirect individuals from justice to treatment. ISP got involved about 2 years ago when they were invited to help start program. East central Illinois task force chose to be pilot program with TASC (Treatment Alternatives for Safer Communities). The initiative includes treatment centers, mental health facilities, churches, etc. and promotes buy in for local law enforcement to participate. Police are the first 10% of the dart deflection process. Patrol sees people at worst moments and people taken away in handcuffs without the third option. Deflection specialist can take over to connect people to services. Deflection Avenues Reconnection Team, aka DART, covers the zone of Coles, DeWitt, Douglas, McClean, Piatt, Vermillion.

ROSC Organizational Update(s)

Darlene will be transitioning to residential for women at Hour House. Darlene thanked everyone for their support over the past few years. Darlene will still be covering the jail education groups while the new Recovery Navigator is in training. Darlene introduced Kandis Mills as her replacement. Kandis has been hired by Hour House but does not begin orientation until the following week. Kandis introduced herself as a Douglas county resident with grown children and grandkids. She is a person with lived experience due to her experience with substance use.

Leanna will be transitioning to a new program under Hour House that will cover Coles and Douglas. It was mentioned that if anyone has a great candidate in mind, to have them apply through Indeed. Leanna will continue as the ROSC Coordinator until a replacement is hired and will assist with the transition. Leanna explained that this is great news to bring additional programs to Douglas County, which will also include an increase in recovery navigators. It was discussed that a recovery navigator page would be beneficial in the newsletter.
