## Spotlight Agency/Program (Family Guidance Center): Kristin Davis

Kristin Induced herself, as the Regional Substance Use Prevention and Integration Coordinator for the Family Guidance Center which started a year and a half ago. Her main office is in Springfield. She worked for the Hour House for 15 years as a prevention specialist and treatment provider.

The Family Guidance Center covers Springfield, Jacksonville, Quincey, and the local area for treatment. They also have served Aurora, Harvey, and the city of city of Chicago and have offices in Toledo Ohio. Her main office is in Springfield. She covers all of Region 4 counties (28).

The Family Guidance Center has prevention services, inpatient and outpatient services, warm hand-off programs, jail services, and 2 mobile MAR Vans. They also oversee a ROSC council in Sangamon County.

The center was created about a year and a half ago and what they do is increase SUD prevention in counties, and increase health equity when it comes to SUD prevention. The population they serve are the ages of 11- mid-twenties. They are looking to partner with youth organizations to look at SUD prevention from a variety of standpoints. They can also help provide technical assistance to grow the services already

in place, provde education for staff and have the staff provide it to parents and or children. If not something they can help establish, they can help connect them to organizations in the area that provide those services. They also help with environmental things like community density, and what the community alcohol density looks like, and procedures and making those connections to see if you want changes or if the county is in compliance.

The Family Guidance Center has an advisory board of individuals from youth-serving organizations throughout the state. They also promote the Illinois Youth Survey and provide YMHFA for any organization that services youth.

## Membership Protocols

Nicki stated that the ROSC membership Protocols have been updated for FY25. The changes that have been made are the ROSC working definition has changed to: A Recovery Oriented Systems of Care (ROSC) is a coordinated network of community-based services and supports that is personcentered and builds on the strengths and resilience of individuals, families, and communities to experience recovery and improved health, wellness, and quality of life for those with or at risk of substance use and/or -co-occurring conditions. The central focus of a ROSC is to create an infrastructure, or "systems of care", with the resources to effectively address the full range of substance use and/or co-occurring disorders within communities.

We have also removed the section that PLEs must be sober, drug-free, and involved in his or her own recovery because we want to be inclusive of all pathways to recovery.

### Subcommittee Meeting Update:

Nicki stated that the council is looking for donations of tea and lemonade for the Recovery Picnic. The website for the recovery picnic t-shirts is up and September 3, 2024, is the last day to order a shirt. CARE donated \$200 for t-shirts to give away at the picnic.

Lisa provided Candlelight Vigil details. We have 150 candles and she wants all of them burning. Nicki and Jessica were able to be at the city council meeting on August 26<sup>th</sup> where Mayor Craig Smith signed a proclamation that recognized 8/31 as International Overdose Awareness Day.
