Presentation

Rebecca Anderson, Executive Director, Perry County Counseling did a presentation on their operational system and shared about the resources they provide across Perry County and the role of the Mobile Crisis Response team. (Information attached)

Services offered:

- Outpatient mental health and substance use counseling for youth adolescents and adults
- DUI assessments and treatment
- In school outpatient mental health services
- Supervised residential home for mental health and/or co-occurring disorders
- Community support program
- Employment services program
- Substance use prevention program for students in 4th- 12th grade in the schools
- 24-7 mobile crisis response
- Shelter diversion program for at risk of homelessness individuals

Membership Protocols

We reviewed the current Membership Protocols and discussed potential changes or updates. It was emphasized that PJRC is our council, and everyone's input is vital to
