

MEETING SUMMARY: The Southland Recovery Coalition ROSC Council Meeting covered crisis intervention strategies in law enforcement by Sergeant Assata Olugbala, emphasizing de-escalation and compassionate care. The United Mental Health Addiction and Recovery Coalition's annual conference had nearly 200 attendees, and Laura Garcia was honored for her community support. The Women's Wellness Walk in Bremen Township had nearly 300 participants. Denise shared about her successful play, "Beyond the Door," based on her life. The council discussed outreach strategies, including an "elevator pitch" for recruiting new members. The next meeting is scheduled for November 20, with an in-person meeting on December 18.

Minute Highlights:

Sgt. Assata Olugbala presented on Crisis Intervention Teams. Background: She's been in law enforcement for 30 years. Formerly worked for the Sherriff's department. Currently serves as a peer support team leader since 2018 and has been a peer support team member since 2008. Trained in Crisis Intervention techniques since 2008. Excited to offer some insight on police response to crisis intervention situations.

<u>Overview</u>

Peer support in law enforcement is offering support to officers who have suffered from traumatic incidents where it's on a level, where they don't need a clinician or something of that level, and once we do an assessment with the officer, if we feel that they need an assessment, we'll refer to a clinician.

There's power in communication! When a call first comes out, and the police are called to a home and we have knowledge, or if it's documented that that home has the history of mental health illness, the first thing the police department will do is look to send a crisis intervention officer. A lot of officers, not every officer, are Crisis Intervention trained, but they try to specifically send a crisis intervention officer to that scene.

Know Your History! There should be a history, and if there's history, they'll educate them before they arrive... what the history is and how they should approach a situation like that. So when the officer arrives, the primary goal is to safely deescalate the situation while providing compassionate care. So once the officer arrives, if they're officer from the district, most likely, they are already familiar with that home, the family member, or who the individual is experiencing a crisis. So we may try to have those resources available before we get there or if there's a person that they connect with, we'll try to make sure that that person is there, to help with deescalating the situation. No time matters but the care for the individual in crisis. It could be 30 minutes. It can be two hours... if we have to spend that time to calm that person down and to we're able to get them to care, or access resources that they need at that time.

Learning Directly from the Community One thing that law enforcement has done was to add a direct source training component within the last six, seven years. Now, when officers are going through our crisis intervention training (which is about 40 hours), and the last two days will include a person who may be a mental health patient or someone who's taking medication. They volunteer to come in to help the officers. So the officer is getting it from this actual source to give them scenarios. If the officers don't respond in a certain way, the volunteer will provide information and encourage them-- how they should respond, what they should say, what they shouldn't say, to get the best response from the individual in crisis at that time. So that has been a big component. It's been a really big help to answer questions, to actually get it from the source of how to approach a situation when the person is not violent, as opposed to a valid violent situation.
