## **Presentation:**

Camille Dorris, Executive Director; Southern Illinois Coalition for the Homeless, gave the background of Southern Illinois Coalition for the Homeless. They serve the lower 24 counties; they have several programs to help individuals find secure housing. Those programs include, but not limited to:

- Transitional housing
- Permanent supported housing

- Specific prioritized housing (HIV positive individuals)
- Re-Entry housing
- Rapid Re-housing
- Diversion

They are looking for landlords to work with them if anyone knows any who might be interested, please let them know.

Individuals can do an intake and application over the phone, in person, or SICH staff with come to where they are. Prioritization is done by the individual's personal vulnerability of being homeless.

If you are helping someone who is on the SICH waitlist please help them stay in contact and keep their information updated with SICH because if it is their time on the waitlist and they can not be reached they will be moved to the bottom of the list, which happens frequently because it is hard for some to keep an active phone number to be reached.

Anthony Arington asked if there are any restrictions for criminal histories? Substance use history? Children?

The only restriction they really have would be sex offenders. They cannot house sex offenders in any of their own housing options such as transitional. Sex offenders, however, could be included in rapid rehousing funding or any of the funding to help them gain their own residence. They are one of the only organizations that help felons, violent offenders, individuals who have been in prison for a long time. They have a prioritized unit just for justice involved individuals. They do not discriminate against substance use, whether it is past or present.
