New Business	<p>The new Community Needs Assessment (CNA) survey draft is due 11/30. SUPR provided 10 questions and we can come up with 10 more. Are we asking the best questions? Last year, we received 61 responses. Resource map is a follow up piece to the CNA. CNA survey findings will be due Feb. 28, 2025.</p> <p>The SUDS Friends & Family community forum was held on Oct. 29th. The forum was put together in response to a need expressed by multiple families in the Chester food pantry line. Unfortunately, none of those families attended the forum. Beverly shared that SUPR may be able to assist with costs of removing barriers of attendance, i.e. hardship – gas card.</p>	<p>John will follow up with families who had asked for support to see where we go from here.</p>

November is Homelessness Awareness Month	November 17-23 is Homeless Awareness Week. Sandy shared that homelessness from the National Point in Time (PIT) count increased 12.1% from 2022 to 2023. The high cost of rent has contributed to that increase. HUD and McKinney-Vento definitions of homelessness were compared & discussed. The 2024 Randolph Co. PIT count identified 15 individuals who met the HUD standard of unsheltered. We feel this number is far higher in reality as data is collected for just one day and to be counted, an individual must share DOB and last four digits of their SS#. Many individuals are not comfortable with sharing their personal information with a stranger.
