- Feeling the pressure of being an African American male not being able to provide for family
- Always an easy way into the illegal lifestyle but harder to get out of it
- We will not ask for help and/or we will not take advantage of our resources
- Felony free society construction company- people coming out the system in need of jobs
- · Coming out of the system and facing housing barriers, employment barriers, mental health barriers
- You have to have the ability to see yourself higher, project higher and go after higher despite of where you are currently
- Be honest with ourselves on what you really need, what you stand for, and what you believe in
- We need resilience to survive and look forward to it. Find people to associate with that have your common resilience and beliefs
- Call to action- list 5-10 people that you can call when you need help and let them know you will be calling them. List 5 places that you do not want to go and/or never going to go. List 5 places that you want to start going.
