Claire Hughes is an Administrator and Director of Business Development at The Little Resource Center in Carbondale. It is a non-political, non-religious social service agency supporting families and expecting parents in Southern Illinois. Staffed by licensed and certified professionals, it provides material, educational, and emotional support, empowering families to be their own best experts through the help of community resources. They serve families in the lower 16 counties of Southern Illinois. They offer FREE Doula Services, diaper and formula bank, car seat and crib distribution, infant, toddler and maternity supplies, case management services, and no questions asked harm reduction supplies. From April to June they served 132 families!
