We Met with Famer City on January 13th we talked about ROSC and the Mental Health Board. We got a yes from Famer City and the Naloxone Box is up and open to the Public in need. The Kenny Fire**

Department has said Yes to having a Naloxone box put up out front that we will be delivering next week!

3. **SURP ROSC SURVEY-** We have 70 Surveys that have been turned in we will be picking up Surveys this week and have them turned in on Friday

She talked about overdose deaths for teens and how males were higher than females. She talked about how The Illinois Department of Human Services has funded the administration of the Illinois Youth Survey since 1990. The IYS is a Self-report survey administered in school settings every other year. It is designed to gather information about a variety of health and social indicators including substance use and perceptions of bullying, school climate, nutrition, and physical activity. The survey is administered for students 8,10,12th grade
