- Adrienne Edwards created a transportation list sent via email listserve. We are hoping to get these resource lists out for different focuses.
- Quote of month: "Snowflakes are one of nature's most fragile things but just look what they can do when they stick together."
- Nathan Nichols Manager with Central Illinois Public Transit and IL CEFS Economic Opportunity Corporation- operate in 7 counties (Shelby, Moultrie, Christian, Montgomery, Fayette, Clay, Effingham) responsible for services door to door. General hours of operation 6-6 PM (see slide). To call and schedule a ride, call toll free 855-755-2478. We like 24-hour notice can do the same day but can't guarantee an opening. You can schedule a ride after hours, but it will go to voice mail. You will get a call back as soon as the voicemail is checked by staff. The cost to schedule a ride is \$3 per stop, children 6-12 \$2. There are monthly passes

- (unlimited (\$35), reduce fair ID cards (application on website). If you are over 60, you can get a card in 8-10 days get via donation, disability \$15 for the card.
- Assisted living facilities use our services regularly have ID cards when boarding—when people from assisted living facilities go on a ride they check out, get on their bus. This is why it's a good idea to have a lanyard. Payment must be presented when you get on the bus. We do have billing agreements with organizations. Don't sell passes because it can be wasteful.
- Medicaid will pay in and out of county. Several MCOs that work with us. We
  recommend anyone that has any type of insurance we have an insurance person
  on staff who can see if insurance to pay for the trip.
- All vehicles are ADA compliant, have lifts, and have ramps for mobility vehicles.
- Can't go into a home, can't go into a facility they must remain in site of vehicles
- You can have your children on the bus, child seats not required but they do need to be secured by the parents.
- If riding in minivans if under 8 or under 40lbs must be in safety seat.
- Transportation we try to be flexible even if it is up to an hour beforehand, sometimes we can accommodate.
- If you have a service animal, it is permitted, otherwise other animals need to be in a carrier.

- We have a dispatcher that speaks Spanish. To get an official translator, we need a certain % of population.
- We are open to everybody we are not just a "senior or disability bus".
- We have quarterly meetings in March and then in October.
- We do track denials to get more funding to get more buses and to get drivers to serve at different times. We have to show the demand to make those changes.
- Funded via State and Federal grants. Counties can donate. We are doing fine in Montgomery County for drivers but in Christian County, we are having a hard time. When we have more funding, we can do more.
- When people call ahead of time, they call for appointments we can't just do a precise time, we can't offer the same time often to multiple people.
- Qualifications for drivers do background checks, have to have a good driving record, felonies could be an issue but give it a try. Must be 21, have a valid driving license, will give you CDL training
- Speaker covers all counties and contact if someone needs a speaker.
- MD went over the slides and clarified that asset map and needs assessment were
  the same document during previous years. This year, the asset map was separated
  from the needs assessment and many of the previous sections had to be moved to
  the needs assessment including priorities for expansion, readiness, demographics,
  technical assistance, etc.
- Any technical assistance that we need? (no answer)

- Update on survey? The goal was 730 cumulatively between Macoupin & Montgomery counties 403 surveys as of this morning. The survey information will go into the needs assessment due in February.
- We need more men to fill the survey because we don't have adequate response rate from men.
- The entire state of IL is also doing a survey so check local ROSC pages.
- Joanna Gonzalez commented that she loved the work on this document having 40 pages is phenomenal.
