- Tracy (Boys/Girls club)- new QR code for families; can go on there and check out incident reports, change address, tax info, etc.- called my club hub→ is in process of migrating process
- Carol (Health Alliance)- just ended annual enrollment for Medicare, but open enrollment for Medicare is happening now- if there are seniors that are needing insurance changes, those can be made until March 30th
- Ryan Bohm (Liv County Sheriff)- update on Cops & Kids program- serviced around 78 kids
 (\$250 each) in Dec to go shopping and spend time with the cops- all donation funding based
- Chrystal Little (Health Dept)- smoking cessation, vaping is included in that; the HD's
 programs serve the entire lifestyle, if you have any specific need, contact the HD; if you
 need "encourage to quit" or IL tobacco quit line cards, reach out to Chrystal; HD does
 provide free NARCAN and NARCAN trainings
- Erin (Health Dept)- had 5-year strategic plan meeting this morning- one main focus is on mental health and behavioral health resources with substance use falling underneath thatthe strategies discussed were transportation, discussed stronger awareness/outreach (potentially creating educational videos), suicide prevention/recognizing when people are in crisis, partnership with IHR for smoking cessation programming
