Summary of Identified Gaps Across the Continuum (FY25):

DeWitt County Identified Gaps Across the Continuum:

- 1. Health Promotion:** Lack of community readiness to address substance use disorder (SUD) issues; Lack of awareness and understanding regarding SUD resulting in increased community stigma.
- 2. Prevention:** Lack of Behavioral/Mental Health services and support for youth and adults.
- 3. Intervention/Harm Reduction:** There is a lack of knowledge and information regarding county access to harm reduction supplies and services.
- 4. Treatment:** Lack of transportation. Lack of SUD and Mental Health services in the county. Lack of funding to support additional SUD Behavioral Health Staff for both youth and adults.
- 5. Recovery Supports:** Lack of recovery housing.
