We are doing Naloxone Training at DeWitt Manner Apartments on March 28th at 1 p.m. Maggie has emailed Cory, and they will talk to the High School about Naloxone Training.
- c. Talk About the Groups-Thursdays and Sundays are doing great! Between 10 and 15 people are attending now. We are doing a support group in the DeWitt County Jail on Fridays at 9 am. We have 2 people who are now in housing who were homeless for some time. This is just one of the many miracles we get to be part of.

Naloxone boxes in locations – We have a Naloxone Box up at the Clinton Library. One up in Weldon at the City Hall. We have one up at Farmer City Library. The Kenny Fire Department has a Naloxone Box. There is one up at the Wapella Fire Department. We have one left! We are trying the town of DeWitt or Waynesville.

1. SURP ROSC SURVEY- We have 92 Surveys! Maggie went over the data with the Council and shared their thoughts on how some of the surrounding towns are different. There was more stigma in Farmer City with Substance use than Mental Health. We did get a good number of people who wanted to know more about ROSC and who already know about

ROSC. More people from Farmer City didn't know much about Substance Use. The data we will use to help Farmer City.
