# **Spotlight Agency/Program Medical Reserve Corps (Connor Dotson)**

Connor provided an overview of the Medical Reserve Corps (MRC), clarifying that it welcomes volunteers from various backgrounds, not just those with medical training. He explained that MRCs operate locally and can adapt to community needs, serving as a resource for both emergency situations and community events. Dotson also noted the historical context of the MRC's formation and its role in enhancing local preparedness.

Connor discussed the need for increased awareness of a new community program, expressing his desire for it to serve as a resource during both in everyday situations and during emergencies. He announced plans for a kickoff event to provide more structure and information about the initiative. Dotson invited anyone interested in participating or collaborating to contact him.

#### **Subcommittee**

Nicki Hanks outlined several upcoming events, starting with a St. Patrick's Day party on March 17, where fun games and giveaways will be featured. She also mentioned the need for volunteers for laundry day and provided details about an all-recovery skate night on April 17 and a recovery flow yoga event on May 15. Hanks encouraged participation and support from the community.

#### **Deliverable Documents**

The group reviewed the gap analysis from the community needs assessment. These results were combined with the Community Survey results, focusing on the categories of health promotion, prevention, intervention/harm reduction, treatment, and recovery. She outlined specific community action steps, ideas for partnerships with outside groups and agencies, and potential changes at the state level, such as providing educational resources and expanding prevention programs. Additionally, she suggested potential partnerships with local organizations. Hanks

also identified the need for increased state funding and support for recovery housing and secondchance employment opportunities.

# EDGAR COUNTY ROSC SUBCOMMITTEE MEETING MINUTES

February 20, 2025 2:30 PM Via Zoom

#### **Warming Center**

The group discussed the opening of a warming center in their area, which was set to close back out on Sunday due to warmer weather. Nicki and Jessica confirmed that the warming center was being used and that they had been working with local volunteers to ensure cleanliness and supplies.

#### **Planning Community Events and Training**

At the meeting, Nicki led the discussion on the upcoming year's community events and training. Since there were no significant updates on the homeless initiative, they decided to focus on planning for the next year. They considered having a "Meet the ROSC event" in Kansas as a potential starting point to integrate themselves into the community. Lisa suggested that they could attend a neighborhood watch meeting in Hume as an opportunity to introduce themselves. They plan to use outdoor games and face painting at future community events. Lisa agreed to inquire about the neighborhood watch meeting in Hume from Scott.

#### **Upcoming Community Events and Volunteers**

Nicki mentioned a Saint Patrick's Day party, a bridge to recovery training with Joe from the Champaign Urbana Health Department, and a skate night at the skating rink. Lisa offered to help with the skate night by contacting Mary Jo Becker. The group also planned a yoga event at Westlake Park and a "Paint the Sky event" at Sunrise Park. Nicki expressed the need for volunteers for these events and planned to distribute sign-up sheets at the council meeting. The team also discussed the upcoming Bridge to Recovery training, which they hoped would help break the stigma around harm reduction in their community.

#### **Community Events and Employer Fairs**

In the meeting, the team discussed various topics including the distribution of flyers, the need for more law enforcement attendance at events, and the potential for second-chance employer fairs. They also discussed the challenges faced by individuals in recovery, particularly in finding employment. The team agreed on the importance of building relationships with potential employers and the need for more

transportation options in the community. They also discussed the upcoming events and trainings, and the possibility of organizing a second chance employer fair in the upcoming year. The team also discussed the ongoing issue of transportation in the community.

#### **CARE Board Member**

Lisa expressed concerns about finding a suitable replacement for a board member who had left their organization, Care. She mentioned that the board member had lived experience, but they were struggling to find someone who could fill the role. Nicki suggested an individual, who has experience with homelessness, as a potential candidate. Lisa agreed to consider this suggestion and asked Nicki to keep her in mind if any other suitable candidates come up.
