Presentation By:

Craig Lynch who has been with Centerstone for 3 years and has been with Connections since August of last year. He has a master's in psychology and a CADC credentialed. He has been in recovery for over 10 years. He is the coordinator for the Connections program that serves 4 counties in southern Illinois: Franklin, Williamson, Jackson, and Union. They work with individuals 18 and older who

currently experience homelessness or at risk of homelessness. The clients must have substance use problems to qualify for this program. They may also have co-occurring with substance use and mental health. The program provides intense case management to overcome barriers which include transportation, employment, and housing. This program helps to build support systems, reduce substance use, improve mental health, and reduce court system involvement. He discussed the critical time interventions of the discharge from a psychiatric inpatient or correctional setting. He discussed the components such as time-limited, phased approach, decreases in intensity over time, community-based, harm reduction approach, and smaller caseloads.

Old Business:

Mandy went over the community survey results:

- 124 total responses but the majority of them were from other states.
- We had a total of 27 responses we could use.
- 85% didn't know what Perry/Jackson ROSC was.
- A majority of respondents were unaware of harm reduction services and MAR treatment
- A majority of respondents did not know what harm reduction or MAR even was.

Mandy noted that we know the community needs to be educated on what Harm Reduction and MAR treatment is and we need to keep that in mind when planning upcoming events.

Last year PJRC partnered with TAT Harm Reduction program and hosted local "Pop-Up" events so that is something we will look into again this year among other events.

Christina Manchen is willing to help with surveys or hosting focus groups in the future.
