

Coles County Recovery Oriented Systems of Care (ROSC) Community Survey

PURPOSE: This survey is to measure public opinion on issues related to Substance use and Recovery. The information collected will be used to identify areas for improvement in our community. DEFINITIONS: The terms listed below are used throughout the survey and are provided to ensure people provide the best educated answer.

Drug Overdose Prevention Program (DOPP) Site

A designated community location (such as a business, library, or community center) that offers free public access to Narcan through a public display.

- Community members can take Narcan anytime, with no questions asked and no personal information required.

Narcan (naloxone)

A safe, life-saving medication that can reverse an opioid overdose.

- It works by blocking the effects of opioids in the brain. Narcan is easy to use, typically as a nasal spray, and has no potential for abuse.

Syringe Services Program (SSP)

A community-based program that provides access to sterile syringes and safe disposal of used syringes.

- SSPs often offer additional services such as HIV and hepatitis testing, referrals to treatment, wound care, and overdose prevention education, including Narcan distribution.
- These programs are part of harm reduction efforts and have been shown to reduce disease transmission and connect people to care.

Harm Reduction

Evidence-based strategies aimed at reducing the negative health, social, and legal impacts of substance use without necessarily requiring abstinence.

- Focus areas include preventing overdoses, reducing infectious disease, and connecting people to care and support services.

Medication-Assisted Recovery (MAR)

A recovery pathway using FDA-approved medications (like methadone, buprenorphine, or naltrexone) combined with counseling and behavioral therapy.

- MAR supports individuals in achieving and maintaining recovery from Substance Use Disorders (SUDs).

Peer Recovery Specialist

A person in recovery from substance use and/or mental health challenges who is trained and certified to support others.

- They offer mentorship, advocacy, and guidance, drawing from their lived experience.

Recovery

A personal journey of change and growth through which individuals improve their health, live a self-directed life, and work to reach their full potential.

- Recovery can involve many pathways, including abstinence, harm reduction, medication-assisted recovery, and peer support.

Recovery Services/Supports

A wide range of non-clinical services that help people in or seeking recovery from substance use or mental health challenges.

- Examples include peer support, housing help, transportation, employment assistance, recovery coaching, and support groups.

Recovery-Oriented System of Care (ROSC)

A coordinated network of community-based services and supports that is person-centered and strengths-based.

- ROSCs aim to meet individuals' holistic needs—including physical, emotional, social, and spiritual—so they can achieve and sustain long-term recovery.

Substance Use Disorder (SUD)

A complex medical condition characterized by uncontrollable use of drugs or alcohol despite harmful consequences.

- Often referred to as addiction, SUD affects brain function and behavior, and may require a combination of medical, therapeutic, and recovery-based support.
