## Special Admission Requirements

In addition to meeting university admissions criteria, applicants should:

- Having an overall undergraduate GPA of 3.0 or a GPA of 3.0 in the last 60 hours of undergraduate study.
- Official transcripts from each institution attended. Official transcripts of undergraduate degrees are required. Transcripts not in English or obtained from institutions outside the U.S. will be evaluated by the Office of Application Processing at the University.
- English Proficiency: International applicants must take one of the tests: Test of English as a Foreign Language (TOEFL) or International English Language Testing System (IELTS) or Pearson Test of English
- Submit two letters of recommendation that support the applicant for graduate study in health administration. Recommendation letters must be from previous faculty and/or from current or previous employers. If the applicant has been out of school or unemployed for more than five years, he/she may petition for a waiver or a substitution of references.
- Submit a Personal Statement for pursuing the Master's Degree of Health Administration.
- The Admission Committee will review all completed applications and may require a brief interview via telephone, virtual meeting or in-person
- Guaranteed Admission: GSU students and alumni (within past 5 years) are eligible for guaranteed admission to the Master of Health Administration program with an overall GPA of 3.00 or in the last 60 hours of undergraduate study at GovState. Undergraduate transcript is required. Letters of recommendation, personal statement, and interview are waived.

## Degree Requirements

Students must meet all university requirements for a master's degree. In addition, students must:

- Enter degree candidacy with approved Degree Candidacy Application;

- Apply no more than one course with a grade of "C+, C or C-" toward degree requirements; When a student made a second "C+, C, or C-" in a class, the student must repeat the C+, C or C-" course only once to meet the degree requirement.
- Earn a grade of "B" or better in the capstone/culminating course (HLAD 8902, HLAD 8110 or HLAD 8111);
- Repeat a course only once to meet degree requirements;
- Complete Self-Assessment of Competency
