Admission Requirements

1. A clinical master's or clinical doctoral degree in nursing with national certification in advanced practice nursing.

OR

A clinical master's or clinical doctoral degree in nursing with documented clinical hours that would qualify the applicant to apply for National Board Certification and APN state licensure if appropriate. Transcripts and adequate, appropriate clinical activity hours are reviewed on an individual basis.

- 2. Transcripts must show evidence of graduate level courses in Health Assessment, Nursing Research, Statistics, Pharmacology, and Pathophysiology.
- 3. Licensure as a registered professional nurse in the state in which clinical practice will occur.

Requirements for the Certificate

The curriculum consists of 24 credit hours with courses divided into theory and clinical practicum.
