# The Master of Social Work (MSW) Program

**Social Work Practice Grounded in a Social Justice Ethos** GovState's Master of Social Work program prepares advanced social work practitioners to provide services to children, adolescents, adults, families, and communities from socially and economically diverse backgrounds. The curriculum is founded on evidence-based/best practices. Students gain real-life experience through our partnerships in the community with over 250+ internship opportunities.

## **Two Programs**

#### The Advanced Standing MSW Program is comprised of 32 credit

**hours** for students who have earned a Bachelor of Social Work (BSW) degree from a Council on Social Work Education (CSWE) accredited program. Achieve your MSW degree in as little as one year (full-time). A two-year part-time option is also available. Students complete 16-20 hours of field education per week at the specialized level (Fall and Spring semesters).

**The Full MSW Program is comprised of 60 credit hours** for students without a BSW degree from a CSWE-accredited program. Achieve your MSW degree in as little as two years (full-time). A three- or four-year part-time option is also available. Students complete 14 hours of field education per week at the generalist level and 16-20 hours per week at the specialized level. Each level requires a Fall and Spring term of field education, totaling four semesters of field education.

## **MSW Specializations**

- School Social Work (to become eligible for Professional Educator License/PEL)
- Children and Family

o Standard Child and Family (choose 2 courses from the available electives)

o Mental Health Subspecialty (electives in understanding the DSM-5 and related interventions)

o Licensed Child Welfare Practice Subspecialty (to become eligible for a child welfare license in IL)

The MSW program is fully accredited by the Council on Social Work Education.

MAIN ENTRANCE

Students who graduate with an MSW can seek clinical and leadership roles in a variety of public/private settings (e.g., advocacy organizations, counseling centers, child welfare agencies (IDCFS), hospitals, private practice, residential settings, schools, veteran administration systems, and more). After earning a master's degree and meeting additional state requirements, graduates can immediately apply to become a Licensed Social Worker (LSW) in Illinois. To become a Licensed Clinical Social Worker (LCSW), 3,000 clock hours of post-MSW supervision and a clinical exam are required (reference the state's guidelines).

# **Delivery Format**

Classes are held in person or on campus and primarily offered in the afternoon/evening (e.g., starting at 4:30 pm). Field Education is completed off-campus within a social service setting in the community.

## MSW Admission Criteria & Curriculum

Advanced Standing MSW Applicants must have a minimum GPA of 3.00 (on a 4.0 scale) in all BSW coursework. If you have earned less than a 'B-' grade in any BSW course, the course will not be accepted.

**Full Program MSW Applicants** must have a minimum cumulative GPA of 2.50 on undergraduate coursework and completion of the Liberal Arts prerequisites listed below:

- Behavioral/Social Sciences (Equivalent of 9 credit hours).
- Science/Mathematics (Equivalent of 6 Credit Hours).
- Humanities/Fine Arts (Equivalent of 6 Credit Hours)
