## **Presidential Management Fellows (PMF) Program**

The PMF Program fellows will perform valuable service to the American people while jump-starting their career. They'll get full salary and benefits as well as challenging assignments, rotations, feedback on their work plus an opportunity to make government work better. (https://www.pmf.gov/)

#### **Minority Fellowship Program (MFP)**

The purpose of the Minority Fellowship Program (MFP) is to reduce health disparities and improve health care outcomes of racially and ethnically diverse populations by increasing the number of culturally competent behavioral health professionals available to underserved populations in the public and private nonprofit sectors. The MFP closely aligns with the Affordable Care Act by addressing the current and projected behavioral health workforce shortages and the need to train providers on recovery-based practices. ### **ORISE Research Participation Program (NIH and FDA)**

The Oak Ridge Institute for Science and Education (ORISE) is an educational and developmental program formed in partnership with Oak Ridge Associated Universities (ORAU) and the U.S. Department of Energy (DOE) through an Interagency Agreement. BARDA ORISE participants do not perform work in place of federal employees, nor are they considered to be BARDA or US Government employees. This program is considered a valuable human capital tool which provides educational experiences and training in public health as a means to introduce highly motivated participants to public health as a viable career field. ## **ASPPH/CDC Public Health Fellowship Program (CDC)**

Association of Schools and Programs of Public Health (ASPPH)/CDC Public Health Fellowship program provides fellowship opportunities in public health practice; supports specific projects that address current or emerging needs of public health through fellowship assignments; provides leadership, mentorship, and professional training in public health, prevention practice, and policy for fellows. The Program's purpose is to enable early career professionals with graduate degrees in public health (Masters and Doctoral level) an opportunity to round out their academic training and gain practical public health experience.

## Office of Clinical Pharmacology (OCP) Fellowship Program for Training in Policy Development and Regulatory Science (FDA)

OCP's Guidance and Policy Team (GPT) hosts an annual one-year ORISE (Oak Ridge Institute for Science and Education) fellowship to train 1 to 2 individuals to conduct OCP and FDA policy evaluations and regulatory science aimed at advancing new drug development and promoting therapeutic individualization.



The Interagency Oncology Task Force Fellowship program trains scientists in research and research-related regulatory review, policies, and regulations to develop a skill set that bridges the two disparate processes.

FDA-National Center for Advancing Translational Sciences (NCATS) Translational Science Inter-Agency Fellowship (FDA)

The Translational Science Interagency Fellowship (TSIF) aims to provide training in both translational science and regulatory science.

### Regulatory Pharmaceutical Fellowship (FDA)

The purpose of the Regulatory Pharmaceutical Fellowship is to train selected candidates in one of three tracks focused on the medical and regulatory aspects of drug information dissemination, drug advertising and promotion, or medication safety.
