Goal 4: To promote and assess Sexual and Relationship Violence Prevention programs, training, and educational services that fosters a culture of gender equity within the campus community.

Objective 1:	Coordinate sexual and relationship violence prevention programming and trainings for the campus community (i.e., Resident Assistants, student orientation leaders and students in leadership positions on campus, and faculty and staff) in partnership with local sexual assault agencies (i.e., YWCA Metropolitan Chicago, and Guardian Angel).
Action Items	Create workshop schedule for sexual violence prevention programming for the academic school year
Responsible Person and/or Unit (Data collection, analysis reporting)	Erica Wade, Director Counseling & Wellness, Kristina Wilkerson, Assistant Director, Advocating for Sexual Assault Prevention (ASAP) team, and counseling interns and staff
Milestones (Identify Timelines)	Conduct at least 2 events per academic semester that focus on domestic and sexual violence prevention
Achieved Outcomes and Results	We conducted 60 events that consisted of programming, training, and psychoeducation to the GSU community.
Analysis of Results (Where outcomes met? Exceeded? Progress towards goal. Implications for AY20 Objectives.)	We served 939 students for our ASAP (Title IX) programming, however, evaluations were inconclusive. We determined that the evaluation process and procedures need to be implemented and improved for future outreach events.

Objective 2:	Develop and implement evaluation procedure to assess effectiveness of sexual and relationship violence prevention programming and trainings
Action Items	Distribute an evaluation form to students after each outreach presentation/workshop
Responsible Person and/or Unit (Data collection, analysis reporting)	Erica Wade, Director Counseling & Wellness, Kristina Wilkerson, Assistant Director, Advocating for Sexual Assault Prevention (ASAP) team, and counseling interns and staff
Milestones (Identify Timelines)	Number and results of evaluations from each outreach session/program
Achieved Outcomes and Results	Based on our findings, ASAP programming evaluations referenced the following 100% of participants indicate an increased awareness regarding gender stereotypes, sexual activities on college campus, and 100% of participants indicated an increased understanding of the difference between healthy sexual activity and sexual assault.
Analysis of Results (Where outcomes met? Exceeded? Progress towards goal. Implications for AY20 Objectives.)	Based on our feedback 75% of participants stated satisfaction with the overall programming, however, future programming will need to consider management of audience (i.e., give speakers a mic, ensure student participant, etc.). In addition, there needs to be increased programming surrounding resources and bystander activities.
